The Homeless Care Council of Northwest Alabama has received notice of funding available from HUD for the Fiscal Year 2015 Continuum of Care Program Competition. **See the schedule for submission deadlines at the bottom of this document.**

The CoC Program (24 CFR part 578) is designed to promote a community-wide commitment to the goal of ending homelessness; to provide funding for efforts by nonprofit providers, States, and local governments to quickly re-house homeless individuals, families, persons fleeing domestic violence, and youth while minimizing the trauma and dislocation caused by homelessness; to promote access to and effective utilization of mainstream programs by homeless; and to optimize self-sufficiency among those experiencing homelessness. The Homeless Care Council of Northwest Alabama will serve as the Collaborative Applicant for the Continuum of Care, which serves Lauderdale, Colbert, Franklin, Marion, Winston and Lawrence counties.

Members of the Homeless Care Council of Northwest Alabama are invited to submit applications for funding under the HUD NOFA for the Continuum of Care Program Competition. If your agency plans to submit a proposal, you MUST contact Krista Manchester at [hccnwal@gmail.com](mailto:hccnwal@gmail.com) no later than **5pm on Wednesday, October 7th, 2015**. See the Project Schedule below for a calendar of dates regarding the submission process.

**Project Applications will be due to the CoC no later than October 20, 2015 by 5pm. Please see the attached revised schedule.**

The review committee will present its recommendation regarding the projects and priority ranking to the HCCNWAL Board for its approval, and agencies will be notified of a final decision on or before **November 5, 2015**.

Final grant projects will be due to the CoC for submission to HUD by **November 13, 2015 at 5pm** via email at [hccnwal@gmail.com](mailto:hccnwal@gmail.com) or in person to the HCC Office at 118 E. Mobile Street, Suite 300, Florence, AL 35630.

If you have questions about whether your proposed project is eligible to be funded in this FY2015 Competition, please contact Krista Manchester at 256-764-5892 before making any project plans. The HUD competition is very specific about what type of projects can be funded and what processes must be in place before submission.

**\*\*\*Remember you must have been an Organizational Member of the Homeless Care Council of NW Alabama for at least one year before this date in order to be eligible to apply. This is per the bylaws of the Homeless Care Council of NW Alabama, which is the designated CoC for Northwest Alabama.**

**It is strongly suggested that any eligible agency wishing to apply for any of the projects above read the NOFA in its entirety. The link to the NOFA is at the top of this announcement.**

Friday, October 9th	Projects will be reviewed and notification will be given for eligibility to apply
<b>October 20, 2015 5pm CST – Late applications will lose points</b>	Project applications are due by 5pm on this date. You must submit a PDF version plus attachments to Krista Manchester at <a href="mailto:hccnwal@gmail.com">hccnwal@gmail.com</a>
	Applicants must provide 6 hard copies of Project Application and Supplementary Report, plus 1 copy of other attachments for committee review and ranking.
November 2 <sup>nd</sup>	Project Review and Ranking Committee will meet to determine eligibility and ranking status.
<b>On or before November 5, 2015</b>	Applicants will be notified of selection by Review Committee and any project revisions or edits needed.
November 13, 2015 by 5pm	Completed Projects are due to the continuum no later than <b>November 13<sup>th</sup> for final submission</b> . Registration in e-snaps must be completed, along with all necessary revisions completed from the review committee.
November 16-17	Final grant application will be submitted to HUD via e-snaps by the CoC on behalf of all projects.
