RESOLUTION

WHEREAS, pursuant to the provisions of Article 2 of Chapter 40 of Title 11 of the CODE OF ALABAMA 1975, as amended, the City Council of the City of Florence, Alabama, previously adopted a resolution declaring that the building and/or structure located at 123 Whisperwood Trail, Florence, Alabama, was unsafe to the extent of being a public nuisance; and

WHEREAS, the City Council of the City of Florence, Alabama, ordered that such building and/or structure be demolished by the City Building Official to abate the public nuisance; and

WHEREAS, said building and/or structure was, in fact, demolished at the direction of the City Building Official to abate the public nuisance at the expense of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FLORENCE, ALABAMA, as follows:

Section 1. The Building Official has made a report to the City Council on the costs reasonably incurred by the City in the demolition of the building and/or structure located at 123 Whisperwood Trail, Florence, Alabama, said report being attached hereto as Exhibit "A" and incorporated herein by reference.

Section 2. The City Clerk gave notice by first-class mail that the costs of demolition would be considered at this meeting to all entities having an interest in the property located at 123 Whisperwood Trail, Florence, Alabama, whose address and interest was determined from the Lauderdale County Revenue Commissioner's records.

Section 3. The City Council hereby affirms, approves, and fixes the reasonable costs of demolishing the building and/or structure and abating the public nuisance located at 123 Whisperwood Trail, Florence, Alabama, set forth on Exhibit "A" and assesses such costs against the parcel of land located at 123 Whisperwood Trail, Florence, Alabama.

Section 4. The costs fixed by this Resolution shall constitute a special assessment against and a lien on the parcel of land located at 123 Whisperwood Trail, Florence, Alabama, and the City Building Official is hereby authorized and directed to file a certified copy of this resolution in the Office of the Probate Judge of Lauderdale, County, Alabama.

Section 5. All actions authorized by this resolution shall be carried out pursuant to the authority granted by the provisions of Article 2 of Chapter 40 of Title 11 of the CODE OF ALABAMA 1975, as amended.
