Business from the Public (5-minute time limit):

Mr. Charles Rose, 1206 North Montgomery Avenue, Sheffield, AL, appeared and made comments in opposition to expanding the c & d landfill. Mr. Rose stated that on March 7, 2017, the City ran a legal notice in the TimesDaily Newspaper stating that the City has applied for a permit to expand the landfill. Mr. Rose further stated that there have been a number of problems over the years with ground water leaking from the landfill cells into nearby Cypress Creek. Mr. Rose stated that the c & d cell is currently working on four acres and that there is still pollution leaking into Cypress Creek. Mr. Rose further stated that if the City would close and cap off the cells, then pollution leaking into Cypress Creek would slow down.

Mr. John Crowder, 421 Nottingham Road, appeared and also made comments in opposition to expanding the landfill. Mr. Crowder stated that he seconded Mr. Rose's comments. Mr. Crowder further stated that the expansion would be approximately 26 acres which involves areas that were used for dumping household garbage. Mr. Crowder stated that construction material will also pollute ground water. Mr. Crowder further stated that all cells with the exception of the four acres currently being used for construction material should have been closed permanently to prevent further ground water contamination. Mr. Crowder stated that the permit application should be withdrawn and the City needs to seek other places for disposal of construction material.

Council Reports and Comments:

Councilmember Edwards congratulated the Animal Shelter volunteers that were recognized tonight. Councilmember Edwards noted that he is struggling to approve Sunday alcohol sales.

Councilmember Edwards thanked Mr. Crowder and Mr. Rose for their comments regarding the landfill.

Councilmember Betterton thanked all the volunteers who participated in the city wide clean up. Councilmember Betterton also thanked the Animal Shelter volunteers.

Councilmember Simmons thanked Rachel Mansell for organizing the city wide clean up.

Councilmember Simmons reminded everyone of the District 1 Community Meeting that will be held on Thursday, March 23, at Mount Moriah Church. Councilmember Simmons also thanked the Animal Shelter volunteers.

Councilmember Bradley also thanked the Animal Shelter volunteers for their service and thanked Mr. Rose and Mr. Crowder for their comments.

Councilmember Eubanks comments follow, to wit:

President Jordan also thanked the volunteers for their service. President Jordan thanked Mr. Crowder and Mr. Rose for their comments. President Jordan stated that he has requested information from David Koonce regarding the landfill permit.
