BY ACCEPTING THE RESPONSIBILITY OF FOSTERING, YOU ASSUME THE RISKS ACCOMPANYING FOSTERING AN ANIMAL FROM THE FLORENCE-LAUDERDALE ANIMAL SHELTER (FLAS). YOU ALSO ARE AGREEING THAT WHEN FOSTERING DOGS/PUPPIES THAT THE ANIMAL WILL NOT BE TETHERED, CHAINED, OR ON A TIE-OUT, ETC. FOSTER ANIMALS MUST NOT BE ALLOWED TO RUN AT LARGE IN ANY CITY LIMITS OR IN ANY COUNTY. YOU MUST CONSULT WITH US BEFORE TAKING A FOSTER TO A VETERINARIAN. IF NOT, YOU ASSUME FINANCIAL RESPONSIBILITY FOR ANY FEES/CHARGES ASSOCIATED WITH AN UNAUTHORIZED VET VISIT. **IF YOU "GIVE AWAY" A FOSTER ANIMAL, YOU ASSUME RESPONSIBILITY FOR ANY FEES ASSOCIATED WITH SAID FOSTER. YOU MAY NOT LIST A FOSTER ON CRAIGSLIST!! YOU MAY NOT TRANSFER A FOSTER TO ANOTHER INDIVIDUAL WITHOUT FLAS APPROVAL. THE FLAS MAY DO AN UNANNOUNCED HOME VISIT AND HAS THE RIGHT TO MAKE ADDITIONAL UNANNOUNCED VISITS IF PROBLEMS OR COMPLAINTS OCCUR.** FOSTERS ARE RESPONSIBLE FOR BRINGING ANIMALS FOR VETERINARIAN APPOINTMENTS, INCLUDING VETTING FOR TRANSPORT, SPAY/NEUTER, ETC. IF THE FOSTER IS HOUSED OUTDOORS, AN APPROPRIATE HOUSE WITH SHADE, WATER AND FOOD MUST BE PROVIDED. ANIMALS COMMITTED TO RESCUE MAY NOT BE ADOPTED. ANY ANIMAL TAKEN ON "FOSTER TO ADOPT" MUST BE RETURNED OR ADOPTED WITHIN THE TWO WEEK TRIAL PERIOD. FAILURE TO DO ANY OF THE ABOVE WILL RESULT IN CONFISCATION OF THE FOSTER ANIMAL AND TERMINATION OF FOSTER PRIVILEGES. THE FLAS HAS THE RIGHT TO REFUSE ANYONE FROM FOSTERING AT ANY TIME AND THE RIGHT TO TAKE POSSESSION OF FOSTER ANIMALS IF THE ABOVE REGULATIONS ARE VIOLATED.
