DECLARATION OF VACATION OF 40 FOOT RIGHT-OF-WAY

WHEREAS, the undersigned, ST. JOSEPH CATHOLIC PARISH, FLORENCE, is the owner of, and the only entity having an interest in, all of the land abutting the platted, unimproved 40 foot portion of right-of-way along the south side of East Tennessee Street in the City of Florence, Alabama as described and shown more particularly on the survey and legal description collectively attached hereto as Exhibit "A" and incorporated herein by reference ("subject right-of-way");

WHEREAS, the said owner desires the subject right-of-way to be vacated; and

WHEREAS, after said vacation, convenient means of ingress and egress to and from their property will be afforded to all other property owners owning property in that tract or those tracts of land embraced in the same map, plat, or survey, either by the remaining streets and alleys dedicated by such map, plat, or survey or by any other dedicated streets or alleys.


