**CONTRACT**

**THIS AGREEMENT**, entered into by and between the **CITY OF FLORENCE**, a municipal corporation, hereinafter called "City," and **CARING PLACE OF THE SHOALS, INC.**, a non-profit corporation, hereinafter called "CARING" witnesseth;

**WHEREAS**, Caring is a non-profit corporation formed for the purpose of, among other things, to have a safe and secure day care center for those impaired by Alzheimer's and other dementias and for those who are frail and/or functionally impaired; and

**WHEREAS**, it is in the interest of the City to develop public awareness of the said need in the Shoals community; and

**WHEREAS**, the City pursuant to Code of Alabama 1975, Section 38-2-9 has the authority to make provisions for the poor and needy of the City, and

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the sum of \$25,000.00, Caring contracts with the City to provide a comprehensive program of community-based adult day service.

The term of the contract will be for the period commencing on October 1, 2024, and terminating on September 30, 2025.

Caring shall provide to the City of Florence a quarterly financial report within fifteen (15) days of the end of each quarter. Such report shall describe the financial condition of the organization, how Florence citizens were served, and how funds paid pursuant to the contract were spent. These reports should be submitted to the City Treasurer, P.O. Box 98, Florence, AL 35631-0098. Failure to provide these reports could result in the loss of future contracts. The City or its authorized representative shall be allowed to inspect financial records and service records of Caring upon request of the City.

It is understood and agreed that the City has no supervisory control over the operation of Caring, and that Caring shall hold the City harmless from any claims that might arise for any reason from the operation of Caring.

The City shall be able to cancel this contract upon a thirty (30) day written notice to Caring.

It is expressly understood and agreed that this contract is entered into solely for the mutual benefit of the parties herein and that no benefits, rights, duties, or obligations are intended or created by this contract as to third parties not a signatory hereto.
