... and between the CITY OF FLORENCE, a municipal corporation, hereinafter called "City," and the **COMMUNITY ACTION AGENCY OF NORTHWEST ALABAMA, INC. - MEALS ON WHEELS**, a non-profit corporation, hereinafter called "MEALS ON WHEELS" witnesseth;

**WHEREAS**, MEALS ON WHEELS is a non-profit corporation formed for the purpose of, among other things, providing a well-balanced meal for the elderly and sick; and

**WHEREAS**, it is in the interest of the City to establish a nutrition program for those who cannot provide for themselves; and

**WHEREAS**, the City pursuant to Code of Alabama 1975, Section 38-2-9 has the authority to make provisions for the poor and needy of the City, and

**NOW, THEREFORE, FOR AND IN CONSIDERATION** of the sum of \$10,000.00, MEALS ON WHEELS contracts with the City to provide weekend meals for persons who live alone and the homebound; and

The term of the contract will be for a period of one (1) year commencing October 1, 2024, and terminating on September 30, 2025.

MEALS ON WHEELS shall provide to the City of Florence the latest annual financial report prepared for your organization. Your report shall describe the financial condition of the organization, how Florence citizens were served, and how funds paid pursuant to the contract were used.

It is expressly understood and agreed that this contract is entered into solely for the mutual benefit of the parties herein and that no benefits, rights, duties, or obligations are intended or created by this contract as to third parties not a signatory hereto.
