ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLORENCE, ALABAMA, as follows:

Section 1. Pursuant to Section 11-43-63 of the CODE OF ALABAMA 1975, as amended, the City Council adopted an ordinance on February 18, 1992 ("1992 Ordinance"), establishing six single member council districts (wards) designated as District (Ward) 1, District (Ward) 2, District (Ward) 3, District (Ward) 4, District (Ward) 5, and District (Ward) 6.

Section 2. Because of population shifts set forth in the 2020 Federal Census, it is necessary to reapportion the existing council districts (wards) pursuant to Section 11-46-23 of the CODE OF ALABAMA 1975, as amended, to comply with federal law.

Section 3. For the City of Florence, Alabama, municipal general election to be held on August 26, 2025, and for every succeeding City of Florence, Alabama, municipal election thereafter, boundary lines for District (Ward) 1, District (Ward) 2, District (Ward) 3, District (Ward), District (Ward) 4, District (Ward) 5, and District (Ward) 6, and the boundary lines for the corresponding voting precincts in each council district (ward) shall be as follows:

(a)(1) The boundary lines for District (Ward) 1 are described as follows:

Begin at a point where Sam Phillips Street and Terrace Street intersect; thence Southwest along Terrace Street to Cherry Street; thence Northwest along Cherry Street to Veterans Drive; thence Southwest along Veterans Drive to Poplar Street; thence Southeast along Poplar Street to the right of way of an abandoned railroad spur right of way; thence Southwest along the abandoned railroad right of way spur to the extensions of Wood Avenue; thence Northwest along Wood Avenue and its extensions to Limestone Street; thence Southwest along Limestone Street 210 feet West of Pine Street; thence Northwest along 210 feet West of Pine Street to Dr. Hicks; thence Southwardly with the meanderings to College Street; thence West along College Street to Cypress Creek; thence North with the meanderings of Cypress Creek to Waterloo Road; thence Southeast along Waterloo Road to Wildwood Park Road; thence Northeast along Wildwood Park Road to Cumberland Street; thence East along Cumberland Street to Stewart Avenue; thence Northwest along Stewart Avenue to Lelia Street; thence Northeast along Lelia Street to Pine Street; thence Northwestwardly along Pine Street to Woodland Road; thence East along Woodland Road to Willingham Road; thence North along Willingham Road to Edgewood Drive; thence Southwest along Edgewood Drive to Pine Street; thence Northwestwardly along Pine Street to Cypress Mill Road; thence West along Cypress Mill Road to Graham Avenue; thence North along Graham Avenue to Collier Avenue; thence West along Collier Avenue to Ridge Avenue; thence Northwestwardly along Ridge Avenue to Seymore Avenue; thence Northeastwardly along Seymore Avenue to North Wood Avenue; thence Northwestwardly along North Wood Avenue to Norwood Boulevard; thence Northeastwardly along Norwood Boulevard to Old Cloverdale Road; thence along Old Cloverdale Road to North Wood Avenue; thence along North Wood Avenue to Fairground Road; thence East along Fairground Road to Chisholm Road; thence Northwardly along Chisholm Road to Gresham Road to the Tennessee Southern Railroad; thence Southwardly along the Tennessee Southern Railroad to Marion Avenue; thence West along Marion Avenue to Chisholm Road; thence Southwestwardly along Chisholm Road to Simpson Street; thence Southeast along Simpson Street to Eugenia Street; thence Northeastwardly along Eugenia Street to Martin Street; thence Southeast along Martin Street to Winona Street; thence Northeastwardly along Winona Street to Lelia Street; thence South along Lelia Street to High Street; thence East along High Street to Bellemeade Avenue; thence South along Bellemeade Avenue to Lombardy Street; thence West along Lombardy Street to Sims Street; thence North along Sims Street to Dulin Street; thence West along Dulin Street to Lelia Street; thence Southwestwardly along Lelia Street to Willingham Road; thence South along Willingham Road to Hawthorne Street; thence West along Hawthorne Street to Pine Street; thence South along Pine Street to Waterloo Road; thence West along Waterloo Road to Locust Street; thence South along Locust Street to Larimore Street; thence East along Larimore Street to Cypress Street; thence South along Cypress Street to Irvine Avenue; thence East along Irvine Avenue to Cedar Street; thence South along Cedar Street to Tuscaloosa Street; thence East along Tuscaloosa Street to Pine Street; thence South to Tennessee Street; thence Eastwardly along Tennessee Street to Henry Street; thence Southeastwardly along Henry Street to Plum Street; thence Southeastwardly along Plum Street to a point 175 feet Northwardly from Limestone Street; thence East 400 feet to Sycamore Street; thence South along Sycamore Street to Limestone Street; thence East along Limestone Street to Willow Street; thence South along Willow Street to Park Street; thence west along Park Street to Elm Street; thence South along Elm Street to 165 feet ; thence West 400 feet to Oak Street; thence North along Oak Street to Park Street; thence West along Park Street to Sam Phillips Street; thence South along Sam Phillips Street to the point of beginning.

(2) District (Ward) 1 is divided into Voting Precinct 0102 with a voting center located at Handy Recreation Center and Voting Precinct 0103 with a voting center located at Sherrod Avenue Church of Christ. The boundary lines of such precincts are described as follows:

Begin at the intersection of Seymore Avenue and Old Jackson Road; thence North along Old Jackson Road to Cox Creek Parkway; thence East along Cox Creek Parkway to its intersection with the Boundary Limit Line of the City of Florence; thence Eastwardly with the Boundary Limit Line of the City of Florence to Cox Creek Parkway; thence Eastwardly with Cox Creek Parkway to the Tennessee Southern Railroad; thence Southwardly with the Tennessee Southern Railroad to Gresham Road; thence Westwardly along Gresham Road to Chisholm Road; thence South along Chisholm Road to Fairground Road; thence Westwardly along Fairground Road to Wood Avenue; thence South along Wood Avenue to Old Cloverdale Road; thence South along Cloverdale Road to Norwood Boulevard; thence West along Norwood Boulevard to Wood Avenue; thence South along Wood Avenue to Seymore Avenue; thence Westwardly along Seymore Avenue to Old Jackson Road and the point of beginning.

Begin at the intersection of Cox Creek Parkway and the Tennessee Southern Railroad; thence Northwardly with the Tennessee Southern Railroad to its intersection of Rose Drive; thence Westwardly along Rose Drive to Chisholm Road; thence Northwardly along Chisholm Road with the meanderings of the Boundary Limit Line of the City of Florence, as it circumvents (including the free standing island of city limits located at the intersection of Section Line Road and Chisholm Road) to its intersection with Gresham Road; thence Westwardly along Gresham Road and leaving Gresham Road at a point where Gresham Road turns Southwardly and continuing Westwardly to a point at the intersection of Darby Drive and Cox Creek Parkway; thence Westwardly along Cox Creek Parkway to its intersection with the Tennessee Southern Railroad and the point of beginning.

The City Clerk is hereby authorized and directed to publish this ordinance in the *TimesDaily* and to file with the Judge of Probate of Lauderdale County, Alabama, a certified copy of this ordinance accompanied by a map or plat of the City of Florence, Alabama, showing the boundaries of all the council districts (wards) adopted herein within five days after the adoption of this ordinance.
