## <u>AGREEMENT</u>

THIS AGREEMENT, entered into by and between the CITY OF FLORENCE, a municipal corporation, hereinafter called "City," and the HOMELESS CARE COUNCIL OF NORTHWEST ALABAMA, hereinafter called the "Homeless," witnesseth;

**WHEREAS,** the City, pursuant to <u>Code of Alabama</u> 1975, Section 38-2-9, has the authority to make provisions for the poor and needy of the City;

**NOW, THEREFORE, FOR AND IN CONSIDERATION OF THE** sum of \$10,000.00 PAID BY THE City to the Council, the Council agrees to use these funds for operational and administrative expenses.

The term of the contract will be for a period of one (1) year commencing October 1, 2024, and terminating on September 30, 2025.

The City shall be allowed to inspect financial records and admittance records of the Homeless upon request of the City, such right of inspection being limited to records kept in connection with the provision of City-funded services.

It is understood and agreed that the City has no supervisory control over the operation of the Homeless and that the Homeless shall hold the City harmless from any claims that might arise for any reason from the operation of the Homeless.

The City shall be able to cancel this contract upon a thirty (30) day written notice to the Homeless.
