In accordance with Section 41-16-50.(a) of the Code of Alabama, in the event a bid is received for an item of personal property to be purchased or contracted for, from a person, firm, or corporation deemed to be a responsible bidder, having a place of business within the corporate limits of the City of Florence, Alabama, whose bid is no greater than five percent (5%) greater than the bid of the lowest responsible bidder, the City of Florence may award the contract to such bidder.

- 6. No prices shall include state or federal excise taxes; state, or local sales taxes.
