- **3.** It is understood that the City of Florence reserves the right to accept or reject any and/or all bids and waive any informalities.
- 4. Following Section 41-16-50.(a) of the Code of Alabama, in the event a bid is received for an item of personal property to be purchased or contracted for from a person, firm, or corporation deemed to be a responsible bidder, having a place of business within the corporate limits of the City of Florence, Alabama, whose bid is no greater than five percent (5%) greater than the bid of the lowest responsible bidder, the City of Florence may award the contract to such bidder.

City of Florence, Alabama Minimum Bid Specifications for a New Forklift

By checking any "No" spaces, the bidder states that the product being bid does not conform to that specification. All variations and/or exceptions must be documented, referencing applicable specification(s), explained in detail on a separate sheet of paper, and included with the bid submission. If the City determines by any means that exceptions exist that were not identified on such list, then that bid will be disqualified as being non-responsive. If no exceptions are taken, it will be assumed that the bid meets all specifications as stated.
