

**RESOLUTION**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FLORENCE, ALABAMA**, as follows:

**WHEREAS**, Sections 11-46-20 through 11-46-73 of the Code of Alabama, 1975, as amended, provided for and regulate general and special elections in cities and towns of the state, except those cities and towns which have a commission form of government; and

**WHEREAS**, Section 11-46-43 of the Code of Alabama, 1975, as amended, prohibits write-in candidates in elections held under Section 11-46-20 through 11-46-73 of the Code of Alabama, 1975, as amended; and

**WHEREAS**, Section 11-46-26 of said Code provides that if only one person has filed a Statement of Candidacy or has been nominated for an office for an election to be held pursuant to Sections 11-46-20 through 11-46-73 of said Code, at the time the deadline of qualification has passed, then such person shall for all purpose, be deemed elected to such office and the Mayor or other Chief Executive Officer shall not cause the name of such person or the office for which his candidacy was declared to be printed on the ballot, but he shall immediately file a written statement with the governing body of the municipality, attested by the City Clerk, certifying the fact that only one person filed a Statement of Candidacy or was nominated for the office preceding the deadline set for an election of municipal officers of the municipality and setting forth the name of such person; and

**WHEREAS**, said Section 11-46-26, as amended, provides that the governing body of the municipality, after receding such statement, shall adopt a resolution declaring the person named in the statement duly elected to the office as described in the statement and shall issue a Certificate of Election to such person; and

**WHEREAS**, the Mayor of the City of Florence has filed a written statement with the governing body of the municipality, attested by the City Clerk, certifying the fact that only one person filed a Statement of Candidacy

for the office of Board of Education - District 1 prior to the deadline and that the name of that person who filed such statement was Vicky Kirkman.

**NOW, THEREFORE BE IT RESOLVED** by the City Council of the City of Florence that Vicky Kirkman be and he is hereby declared duly elected to the office Board of Education-District 1 in the City of Florence for the term of office commencing on the first Monday in November, 2025, and

**BE IT FURTHER RESOLVED** that the Mayor of the City of Florence be and is hereby directed to issue the attached Certificate of Election to Vicky Kirkman for the office of Board of Education - District 1 for such term pursuant to the provisions of Section 11-46-25, as amended.
